### 1. Notes Concerning The License Codes

### 2. License Rates / Warranty / Alterations / Misapprehensions

All prices are net in Euro plus legal VAT provided the companies concerned are located in Germany. If they provide their sales tax ID number, EU companies shall not be liable to pay 19% extra sales tax. However, they shall be liable to pay VAT on the purchased products in their own country and might have to pay additional shipping fees on hardware orders.
